## GDPR IS THE LAW

- EU law on data protection & privacy
- All individuals within the EU Economic Area
- Also applies to export of data outside EEA
- Yes, GDPR affects U.S.-based businesses

## NATIVE O365 GDPR

- Does include some tools
- You're going to need more

## FAILURE TO COMPLY

- Up to 20,000,000 Euros or
- 4% of revenue, whichever is greater

- Discover: Supersearch to find anything
- Classify: eDiscovery saved search and tags
- Review: Mark data for DPO evaluation
- Take Action: Data sharing and/or deletion
- Report: Audit logs confirm compliance

## USE CASE 1: ERASING EU USER

- EU customer "Right to Erasure" request
- GDPR Article 17-1
- Must comply without undue delay
- Easily fulfill using Dropsuite

## USE CASE 2: DATA DESIRING EU CUSTOMER

- Wants copies of all their data
- GDPR Article 15-1
- Must provide a copy of all data
- Easily fulfill using Dropsuite

## USE CASE 3: INFORMATION REQUESTING REGULATOR

- GDPR team of regulators
- GDPR Article 31
- Must provide a copy of all data
- Easily fulfill using Dropsuite
