This means users can search the evidence base and find effective treatments using the same language already used for assessment, making a seamless connection to planning care."

PWEBS provides a searchable database that summarizes the latest science about effective youth psychosocial treatments based on expert review of published research that meet robust, defined quality standards. It provides users with a place to find information on which treatments are effective, common practices and other features of effective treatments with primary sources of the information. PWEBS is useful for identifying promising strategies based on what's worked in research studies, quickly and easily obtaining knowledge from hundreds of studies to find results relevant to individual youths, and the ability to prioritize which practices to use, and when.
