





### COST MANAGEMENT

#### **MEDICAL COST PROJECTIONS**

#### LIFE CARE PLAN REVIEW

- Comprehensive review of plaintiff life care plan to ensure appropriateness.
- Recommendations for obtaining a rated age will be made when appropriate.
- Customized report will separate noninjury related medical issues, medications, and treatment.



#### **MEDICARE SET ASIDES**



- A cost analysis of the amount of dollars that should be set aside in an interest bearing account for future injury related medical expenses of the type typically covered by Medicare.
- Allocations are based on rated age of the injured party and provide cost of non-Medicare items covered in the settlement with inflation factors considered.
- Medicare Set Asides are performed by Life Care Planners and Medicare Set-Aside Consultant Certified.
- Lombardi Associates are experts in Medicare Conditional Payment assignments.
