The review is specific to IT and data center service providers. The audit accounts for the system of the data center, and the suitability of its design of controls, as reported by the company. The audit also includes verification of an auditor's opinion on the operating effectiveness of the controls.

Data Ticket successfully performed the SOC 2 Type 2 audit against security and availability, proving they are taking appropriate measures to assure its systems are protected against unauthorized access. The comprehensive report examines multiple controls over the security and availability of its hosting services.
