Each of the three certifications is valid for five years and is delivered in a modular format with lessons, assessments and quizzes to test mastery of subject matter. In addition, SIG University students have access to one of the largest banks of available sourcing data in the U.S. through the SIG Resource Center, which houses over 5,000 tools, templates, methodologies, processes, whitepapers and archived presentations.
