




HIGH PERCENT OF REO's START IN BANKRUPTCY



Currently (BEFORE COVID)

It is rarely talked about but about 40% of all REO's go through bankruptcy first. In most cases the trustee abandons the real estate asset which leaves the homeowner facing foreclosure litigation, which ends up as an REO.





Projected (AFTER COVID)




