#### **\$7.5 Million** - *Bicycle Accident*

45 year-old male bicyclist was hit by a driver who drifted off the roadway and into the bicycle lane. Client sustained multiple fractures, various surgeries and ultimately amputation of his leg. *Steinger, Greene & Feiner* was able to obtain a recovery of \$7.5 Million for our client.

#### **\$2.2. Million** - *Automobile Accident*

37 year-old man involved in auto accident when the defendant switched lanes on I-95 into our client's path and vehicle. After both neck and back injuries which resulted in surgery, the insurance company offered no money (zero, zilch, nothing!) After a lengthy trial, *Steinger, Greene & Feiner* was able to recover \$2.2 Million for our client.

#### **\$2 Million** - *Rear-end Collision*

Married father of two and a full-time chef, our client was rear-ended by a garbage truck. He sustained injuries to his neck and back as well as head injuries. *Steinger, Greene & Feiner* recovered \$2 Million for our client.



## Workers' **Compensation**

We protect the rights of injured workers and their families. Your family's needs do not stop when you have been hurt and cannot work - if anything, their needs only become greater.

Florida law mandates that workers' compensation benefits be provided without delay by an employer to their employee. If your employer or its insurance carrier does not cooperate, you need the help of an experienced law firm like *Steinger, Greene & Feiner*.

### **\$409,000** - *Head Injury*

A construction worker sustained a closed head injury after falling from a crane. *Steinger, Greene & Feiner* represented him throughout his claim and secured a substantial recovery of \$409,000.

### **\$247,500** - *Head & Face Injury*

## *Premises* **Liability**

Premises liability cases involve incidents whereby a property owner is held financially responsible for injuries occurring on his or her property due to negligence. Cases that fall into this category are most commonly referred to as “Slip-and-Fall” claims and occur as a result of dangerous, unkept or hidden conditions on the grounds.

### **\$1 Million** - *Premises Liability*

After a man was shot and killed by robbers at a grocery store, a \$1,000,000 settlement was secured for the surviving family due to poor security on the part of the store owners, which allowed for such a tragic loss to have occurred.

### **\$137,000** - *Premises Liability*

A client sustained a shoulder fracture after tripping over a loose board on a neighborhood walking bridge and was awarded compensation from the responsible party's insurance thanks to **Steinger, Greene & Feiner**.



### **\$350,000** - *Slip & Fall*

**Steinger, Greene & Feiner** effectively secured a \$350,000 verdict for a client who broke their ankle falling down a poorly maintained stairway at her condominium.

## *Child Sexual Abuse*

Child sexual abuse is a terrible tragedy that can have a long-lasting impact on any victim. Child sexual abuse lawsuits afford victims and their families the right to make a claim for damages against an organization or entity that tragically allowed the abuse to occur, by either looking the other way, or being neglectful in properly and adequately supervising children.

### **\$6 Million** - *Day Care Center*

A mother's complaint about an 80-year-old volunteer at a children's day care center led to an investigation revealing the molestation of four children ages 4-5. After the volunteer was sentenced to 20 years in prison, 3 of the parents turned to *Steinger, Greene & Feiner* for advocacy. Our firm recovered \$6 Million in restitution for the neglectful supervision of the children, allowing the molestation to go unnoticed.

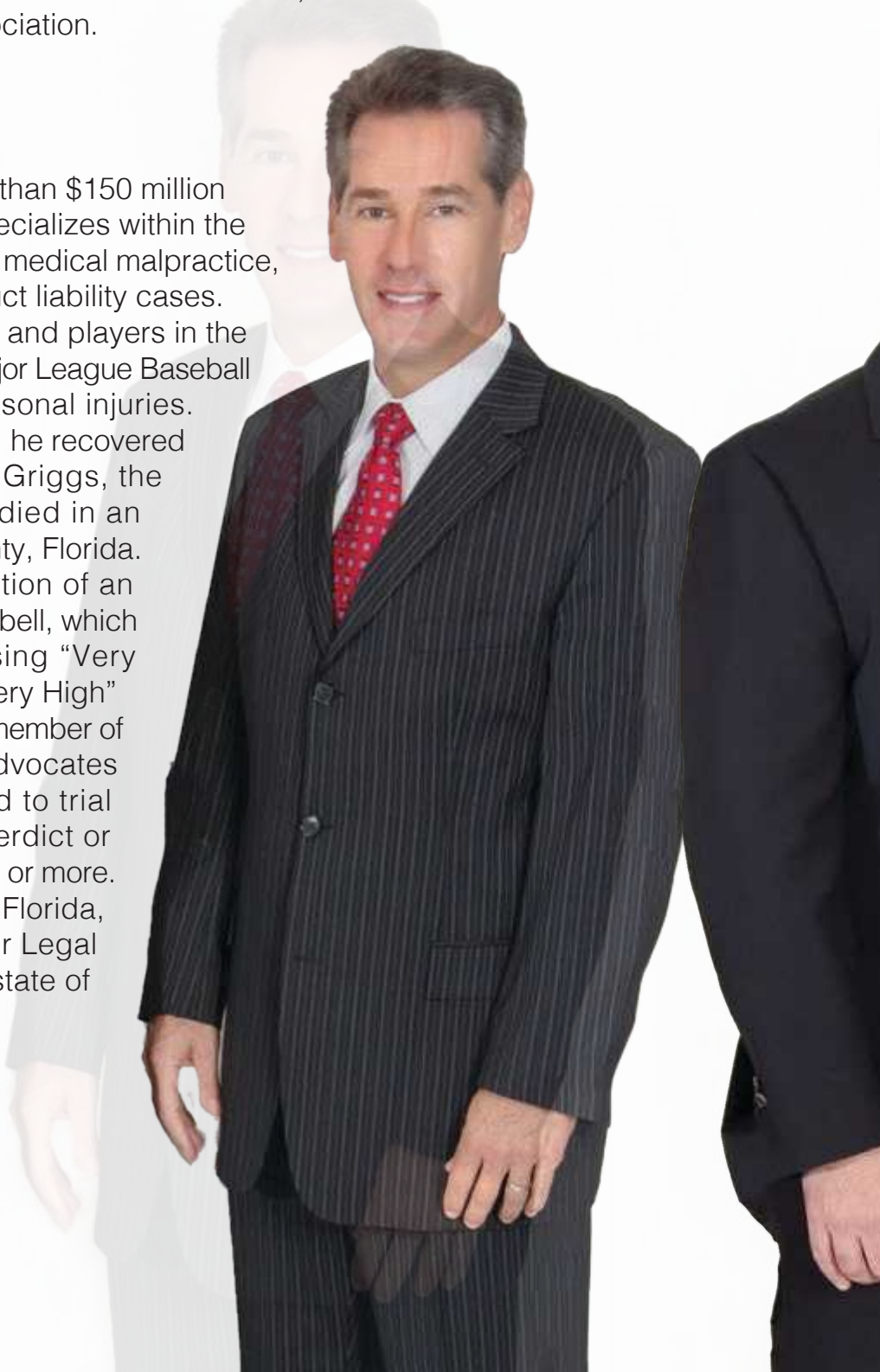
