# Washington County Commissioners Approve C-PACE Clean Energy Loan Program

Optimize Renewables championed C-PACE As a Way to Make Energy Efficiency, Resiliency, Renewable Energy, and Water Conservation Projects More Affordable for Washington County Businesses and Non-Profits.

**HAGERSTOWN, MD – April 28, 2022** – On March 1, 2022, the <u>Board of County Commissioners</u> of <u>Washington County</u> approved an Ordinance to Adopt the Clean Energy Loan Program, enabling property owners to take advantage of <u>Maryland's Commercial Property Assessed Clean Energy</u> (C-PACE) program.

C-PACE is an innovative and affordable way for commercial, industrial, agricultural, and nonprofit building owners to pay for energy improvements. They can use private capital to finance 100% of their energy efficiency, renewables, and water conservation upgrade projects which are then repaid as a long-term benefit assessment on the property tax bill over a term of up to 20 years.

"The C-PACE program will propel energy efficiencies in Washington County, MD," said <u>Jeffrey C. Cline</u>,

President of the <u>Board of County Commissioners of Washington County, MD</u>. "More efficiency means

less fuel required to generate energy, meaning lower costs for the provider and cheaper prices for the consumer."

"Implementing the C-PACE program in Washington County means energy upgrades will be more accessible," said Susan Grimes, Director of the Washington County Department of Business

Development. "It will allow property owners to reduce energy and operational costs and improve the overall value of their facilities."

C-PACE allows property owners to produce a new line of capital, create loans with up to 100% fixed-rate financing, and achieve a 20-year payback that can be cash-flow-positive from day one, while concurrently adding to the value of their commercial asset.

"The projects that C-PACE enables can result in energy consumption and cost savings for commercial and industrial organizations, municipalities, universities, schools, hospitals, and agricultural concerns," added Len Jornlin, CEO of Optimize Renewables, a clean and renewable energy developer and financier in Hagerstown that championed the program for its Washington County clients. "It can help local employers like ConAgra and Meritus Health achieve their business, sustainability, and resiliency objectives while reducing their facilities' greenhouse gas emissions, which – in turn – will reduce our county's carbon footprint."

C-PACE loans typically require little or no down-payment, provide long repayment periods, and afford relatively low interest rates, making eligible projects more attractive and cost-effective. Across Maryland, many county programs have selected designated lending partners with experience in originating C-PACE loans, but businesses may work with any private finance source.

"C-PACE is yet another tool to assist Western Maryland businesses in overcoming barriers to a sustainable energy future, especially necessary as the region begins to balance the extraction economy with the clean energy economy," noted **Andrew Sargent**, Senior Business Development Representative for the **Maryland Department of Commerce**. "The public-private partnership approach exemplified by Optimize Renewables and Washington County's efforts here have enabled us to take the necessary steps toward reducing energy use while spurring job growth and economic development."

C-PACE was launched after Maryland State Government signed legislation in May of 2014 enabling the financing program. It subsequently spread across the state as counties individually set up their local PACE programs. With the addition of Washington County, 19 Maryland counties have passed PACE-enabling legislation with dozens of projects completed.
