### Adverse Action(s)

I filed a charge of discrimination against Equinox on 12/22/22 (Charge number 488-2023-00143). Since then, I have suffered negative job actions because I complained. I have been routinely harassed by management and experienced nit-picking and power tripping. On 4/30/22, I was given no review for Spring 2023. The first charge alleged that all four of my classes were taken away from me by a manager. One of those classes she gave them to herself, and then gave that specific class to another white female instructor on 5/4/23. I have a prescribed psychiatric service animal named Angel, that I have had for five years. On 5/8/23, I received a phone call from the general manager telling me he heard that I had a dog at the club. I called him back and notified him that I have had a service animal at the club over 30 times. He then emailed me on 5/8/23, and 5/15/23 telling me that I had to contact a third party for review before I could bring my service animal back to the club.
